- 5. Corrections to the 2024 Assessments File The assessment file occasionally needs corrections because parcel numbers are incorrect or no longer exist for various reasons. The county has found a few duplicates in the BLSD file, Lake has made corrections.
- 6. Resolution #23-03 Collection Request to Treasurer for 2024 The board reviewed a draft last month; it has now been completed with the exact dollar amount. **It was moved, seconded, and was unanimously passed to approve Resolution #23-03.**
- 7. Resolution #23-02 2024 Budget with Inflation Contingency Lake has added the inflation contingency to the 2024 budget. This will replace the previous spreadsheet included with Resolution #23-02.

- 11. Ditch Maintenance Lake got a call today from Road Services who are going to check out the ditch again within the next week. Lake asked them to contact the Stormwater departments to try to get to the bottom of the issue if the problem is not within the county limits.
- 12. Items from the Floor *OrgSupport will add Outstanding Warrants to the next agenda*.
  - a. Next meeting February 19<sup>th</sup>. No meeting in January.
  - b. Lake should know in about a week if there is a second candidate for the open position and an election is needed.
